### **Summary Description**

Responsible for the clinical component of the Mercy Ships Safe Surgery course at sites remote from the ship, often throughout the host country.

This position involves traveling throughout the host country by Mercy Ships vehicle (where possible), bus, taxi and plane and staying in local guesthouses and/or hotels. When not actively engaged in training (weekends and holidays), the position will be based either on board or at a Mercy Ships offship housing facility. This position is part of a team consisting of one other Safe Surgery Project Facilitator, the Safe Surgery Project Manager and where possible, two local doctors who are interested in Global Surgery, who act both as translators as well as delivering the teaching themselves.

# **Essential Duties and Responsibilities (include but not limited to)**

To perform this job successfully, an individual must be able to perform each essential duty satisfactorily:

- Using Mercy Ships designed Safe Surgery curriculum and materials, responsible for teaching local health professionals. Topics include safety in the Operating Room, fluid management, teamwork and communication, pain management and how to implement the World Health Organization Surgical Safety Checklist. Teaching will also cover Lifebox (pulse oximetry) training, how to count compresses/swabs at the beginning and end of an operation
- Responsible for updating, adjusting and developing curriculum and materials, such as PowerPoint Presentations and laminations, as necessary
- Responsible for training two local doctors how to use the training materials so they can successfully train others
- Responsible for collecting data in each training hospital, performing baseline assessments using standardized questionnaires on facility data, staff attitudes and course feedback.
- Responsible for maintaining records of participants, curriculum updates and changes, locationspecific teaching, materials and equipment donations and evaluation data to ensure among

- others and thorough documentation of the implementation of the World Health Organization Surgical Safety Checklist throughout host country
- Assist the Safe Surgery Project Manager to ensure organization of resources for successful outcome of training objectives
- Assist the Safe Surgery Project Manager with logistics of the project where necessary
- Other duties as assigned
