#### **General Duties & Responsibilities**

- To provide clinical advice and support to clinical quality workstreams
- To respond to enquiries received by the clinical quality team requiring medical and anaesthesia expertise
- To escalate important or serious issues relating to anaesthesia raised by the medical profession, patients or members of the public through CQRB and Council
- To represent the RCoA to multidisciplinary stakeholders

#### **Specific Duties and Responsibilities**

- To respond to enquires received by the clinical quality team that require medical anaesthesia expertise, requesting further advice from those with relevant, up to date knowledge and experience where appropriate
- To work with the clinical quality team and SALG co-chairs to respond to regulation 28: prevention of future death reports received by the RCoA, liaising with experts and multidisciplinary stakeholders where appropriate
- To act as the clinical lead for Invited Reviews, providing day to day advice on the appropriateness of invited review requests and working with the team to improve the invited review service
- To attend Council meetings as an observer to provide clinical advice as and when required
- To participate in RCoA boards and committees as a co-opted member, including the following:
  - Clinical Quality and Research Board,
  - PatientVoices@RCoA,
  - Patient Information Group,
  - Anaesthesia Clinical Services Accreditation (ACSA) Committee,
  - Standards Committee (electronic group),
  - Guidelines for the Provision of Anaesthetic Services (GPAS) Editorial Board,

#### Remuneration

The post is supported by a fixed supplement, payable to the postholder's employing trust or board to enable the successful candidate to dedicate a minimum of 8 hours per week to the role. Specific hours and days of working are flexible and should reflect the ongoing needs of the post.

In the event that the postholder retires from clinical practice during the appointed period, there would be no direct remuneration available.

#### Period of commencement and operation

The postholder will commence their duties in July 2023 for a period of three years, subject to an annual performance review.
