### General Duties and Responsibilities

To take an active role alongside, and in support of the Global Partnerships team in developing and delivering the Global Partnerships strategy.

To provide advice, guidance and support to trainees, trainers, members and external organisations on all issues relating to global health, overseas placements, training and collaborations.

### Key tasks and Responsibilities

Supporting training and education for UK anaesthetists in Low Middle Income Countries (LMIC)

- Work with the Global Partnerships Manager and Global Partnerships Administrator to identify partnership opportunities to benefit both overseas health systems and UK trainees.

Develop the Medical Training Initiative (MTI) Programme and Global Fellowship Scheme (GFS)

- To Chair the MTI Leadership Group and take a proactive role in developing guidance, policy and QI activities around the schemes, with the support of the Global Partnerships team.
- To develop and maintain the sponsorship schemes by approving overseas doctors and proposed placements within NHS Trusts, alongside other members of the Leadership Group.
- To develop processes to monitor the quality of placements and the performance of sponsored doctors in training placements.
- Liaise with Academy of Medical Royal Colleges (AoMRC), Postgraduate Deans, Local Deaneries, Regional Anaesthesia Advisors, ICM Regional Advisors and ICM Faculty

Tutors, Programme Directors on matters relating to the training requirements of sponsored overseas doctors.

Providing advice and guidance for doctors trained overseas

- With the Global Partnerships Manager and the Global Partnerships Administrator, advocate for, and develop resources supporting International Medical Graduate (IMG) inductions into the NHS.
- To provide career advice to IMG doctors with the support of the Global Partnerships Manager and Global Partnerships Administrator.

Miscellaneous

- To attend Regional Advisors, College Tutors meetings and any other RCoA meeting(s) or event(s) which are relevant to the role.
- Representing the College on external committees, working groups and projects as required.
- Any other duties which might be reasonably required by the Global Partnerships Committee or the ETE Board.
- Member of the Training Committee and advisor to the ETE Board on policy relating to Global Partnerships and overseas doctors.
- Attending Academy of Medical Royal Colleges' Global Health Forum.

- Practising consultant and trainer in Anaesthesia in the NHS.
- A Fellow of the Royal College of Anaesthetists.
- A demonstrable knowledge of experience and interest in Global Health matters.
- Knowledge of the current CCT programme in Anaesthesia.

- Ability to draft and explain complex policy matters to a variety of audiences.
