# THE ROLE

The role holder will lead on the key tasks and responsibilities of the Maintenance and Development Advisory Group. The role will provide leadership for the clinical input, liaison and problem solving for the effective operation of the LLP. The role holder will work collaboratively with the staff and across specialty areas, consider and take account of the varied ways in which the LLP is used across the membership of the RCoA and FICM, and contextualise and problem solve issues faced in the effective running of the LLP. They are expected to actively contribute to the governance of the Lifelong Learning Platform (LLP), evaluate suggestions, make recommendations for updates, and support its users.

# **DUTIES AND RESPONSIBILITIES**

Working closely with the LLP Product Manager, the role holder will have the following duties and responsibilities:

- Provide representation to the College Council and to the Education, Training and Examinations Board that College funds for the LLP are delivering a measurable return on investment.
- Assist with regular reviews and updates of the LLP to meet the needs of users, including evaluating and presenting findings from LLP Surveys.
- Review and assist in the development of policies and procedures that help manage the LLP and support efficient use of it.
- Help to develop guidance and support for users of the LLP and disseminate this widely.
- Monitor current performance of the LLP through reviewing usage data including common queries and change requests.
- Recommend appropriate educational and training resources needed to support users of the LLP and advise on commissioning their production.
- Identify opportunities in which official communication channels can be used to promote the LLP.

- Providing clinical contextual information and advice on proposed changes
- Review on an annual basis if the best option would be to continue with the LLP as a bespoke system or to instead explore an 'off-the-shelf' product.

The role holder is expected to uphold the vision and values of the College and Faculty of Intensive Care Medicine and to draw any matters of concern initially to the LLP Product Manager.
